Terms and Conditions:

Deposit - A deposit of \$400 per person is required to confirm a reservation. Final payment will be due to Fuel True on or before Friday, October 15th, 2021. All deposits and final payments may be made by cash or check.

Cancellation - All cancellations will be covered by travel insurance. Any cancellations made prior to the day of departure (January 23rd, 2022) will receive a full refund of the trip payment minus the cost of the travel insurance of \$249 per person. Insurance is fully non-refundable at purchase and is included in the price quoted for the package.

Documentation - The Dominican Republic requires a valid U.S. passport to enter their country which must have a validity extending a minimum of six months following your departure. The passport card is not valid for international travel by air. A tourist card will be given to you on your flight to fill out prior to arrival in Punta Cana. At this time proof of COVID-19 vaccination is not required but it may exempt you from random testing. Rules and requirements pertaining to COVID-19, vaccinations, and testing are subject to change making the travel insurance all the more important.

Travel Insurance - Due to the uncertainty of travel this year and the on-going COVID-19 pandemic, we have included travel insurance for everyone traveling this year. This insurance is cancel-for-any-reason, so anyone on the tour is able to cancel up to 24 hours prior to travel, and receive a full refund of all travel cost minus the cost of the travel insurance. USA Requires a negative Covid test result within 72 hours of return to the US.

Please Note: The features and price outlined are based on a minimum number of full-paying passengers participating on the program. Costs are subject to change pending any currently unforeseen increases in existing tariffs and / or government taxes or airlines fuel surcharges.
